Please bring your GE and business license and have receipts available.

Application deadline is Friday, July 6, 2012. This application and check must be timely mailed to KUMC's above address. Confirmation of KUMC's acceptance of this Application will be sent to you and **must be presented at registration on the day of the Fest.**

Registration sign-in and booth set up is from 7:00am to 8:30am. Booth set-up must be completed by 8:45am. Unloading must be completed by 8:30am as your vehicles must be parked in a designated vendor parking area. You must remain open for sales until Fest closing at 3pm. At closing, please do a courtesy check-out and complete a survey of the event. KUMC appreciates receiving your constructive comments and recommendations.

You are also solely responsible for the security of your items and for performing a thorough clean-up of your assigned space following the event.

KUMC will be exercising its best efforts to advertise and promote this event, but highly recommends you also promoting this event via any media currently used by you to facilitate having a successful and fabulous event for all.
